Important Instructions to Institutes and Candidates for Extended Round 4 as per Hon. High Court order in WPL 3503/2017.

The Procedure for Institute Level Round IV of LL.B-3 Yrs. was detailed in Notice No. 59 & 60 and the Institutes conducted the Round Four Admissions through their log in by accepting Off line application forms and generating merit list, verifying the credentials of the candidates uploading the admission status and generating the Admission letter, as per the detailed schedule given in Notice no 59 and 60 . The Cut-off date of admission for the Academic Year 2017-2018 was 7th December 2017..

Many Colleges of Law and Candidates had approached Directorate of Higher Education and Commissioner ,State CET CELL for extending admission date which was out of the purview of the CET CELL.

A candidate filed a Writ Petition in Hon High Court, Mumbai vide WPL-3503/2017, in the order Hon. High Court has directed CET CELL to reopen the admission link. As per the order CET CELL is issuing **Notice No. 61** with schedule of **Extended Institute Level Admission for LL.B-3 Yrs. Course as under-In order to ensure maximum admissions in the Colleges in the Extended Round 4 (Institutional Round)**, CET CELL will open the Application Form (Part I) editing link and the Admission Schedule for Extended Round IV will be as follows-

3. The Schedule given in Notice No & 9 is indicative, Institutes can prepare and publish their own schedule within the frame work available above .
8. In view of unconfirmed applications and wrongly filled applications requiring correction in their personal details like: i) Category, ii) Candidature Type iii) Gender iv) Date of Birth v) Minority Type vi) Marks of Qualifying Examinations v) Filling in wrong degree or reporting Post Graduate Diploma as PG Degree etc. editing link will be open as shown in row 3 in the schedule given above.

The Institute's Log in will have following links available: -----

- a) **View Vacancy:** From this Link the Institute will be able to view the Category and Candidature Type wise vacant seats in the college available
- b) **Generate Merit List:** From this link the Institute will be able to generate the merit list by keying in Application id separated by (,) Comma. The Institute should generate separate merit list category wise, Quota wise etc. and fill in the seats as per the directions given in Notice No 59 (a, b, c & d).
- c) **Admit Candidate:** for this Institute will get two links i) Admit Candidate against CAP ii) Admit Candidate against Institute Quota. From this link the Institute should generate Provisional Admission Letter.
- d) **Confirmation of Admission:** The institute will verify the credentials of the candidate, candidature type, category, qualifying examination marks as per the provisions in the Government Notifications and the Information Brochure. Any wrong admission will be responsibility of the Principal of the College. The college will upload the admitted status and then generate the Provisional Admission Letter.
